Camp Rules

To ensure the best stay for all at Leithfield Beach Holiday Park, Campers are asked to respect the following :

DOGS Dogs are allowed in the camp at the discretion of the camp management only. Being able to have your pet here whilst on holiday is a privilege, not a right. If your dog's presence should cause distress to other campers, you may be asked to remove it.

Dogs MUST be on a lead at all times when in the camp, If tied whilst onsite, the total length of the lead should not exceed 2 metres so as to not impede other campers

No dogs are permitted near the camp facility buildings Doggy 'doos' must be cleaned up immediately Excessive barking or aggressive, territorial behaviours may also result in the owners removing the dog

This may seem excessive to some, but not all people enjoy the company of dogs and we would like to ensure that all campers, especially children feel safe within the camp environment at all times.

Vehicles The speed limit within the camp is 10 km, or walking speed. Please keep an eye out for children, especially little ones on bikes; they can come out of nowhere. Normal road rules apply - vehicles should only be driven by licensed drivers.

Motorbikes / ATV's / recreational vehicles are only to be used enroute to exit the camp and NZ legislation is to be adhered to in regards to helmets and the age of the rider The constant noise of vehicles does upset other campers at times so please restrict their use between the hours of 9 am to 9 pm.

Bicycles. Children must wear bicycle helmets when riding their bikes as per NZ legislation

Visitors There is no visitor parking provided in the camp. This is for campers only. Visitor parking is at the front gate Any visitors locked in will be expected to pay the appropriate camp fee.

As per Health and Safety Regulations, visitors must sign in/out at the camp office

Recycling We encourage all our campers to recycle. Please use the bins provided. Take care when disposing of rubbish in the bins throughout the camp, especially the noise level either early in the morning or late at night

Noise No excessive noise after 10.00 pm

Fires DOC regulations state there are to be NO openfires.

Awnings / Tents left up in the owner's absence are at the owner's risk

Power usage Power cords left plugged in after the owner has left the camp may be unplugged by camp management unless prior arrangement has been made. A fee will be applied in this situation of \$30 per month.

Warning; It is illegal to connect your caravan to power without a current Electrical Warrant of Fitness or take power into a tent / awning unless through an approved RCD electrical safety cord

Takeaways Hectors Food caravan is open on Fridays and Saturdays 5 pm til 7.00 pm, the food caravan may be open at other times e.g. some long weekends. Please keep an eye out for notices advertising these nights.

General Please keep the camping ground tidy and treat the facilities with respect. Please inform Management of any issues that arise as soon as possible.

Camp buildings No bikes_allowed around to be ridden or parked around the buildings; they can be a tripping hazard.

No dogs around camp buildings or inside camp owned rental units
